The Fund seeks to provide current income consistent with liquidity and preservation of capital.

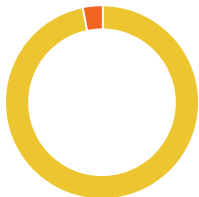
## Investment Strategy
