Objective

The Fund seeks to provide long-term capital appreciation.

Investment Strategy

The Spectrum Fund pursues its objective by taking long and short positions in the global securities markets. The Fund primarily invests its long positions in common stocks and investment companies which include domestic and foreign mutual funds and exchange traded funds. In most circumstances, the gross exposure of the Fund will exceed 100% of net assets, which will typically be offset by the Fund's short positions. The Fund implements short positions in anticipation that a security will underperform due to deteriorating value. The Fund also incorporates Meeder's Defensive Equity strategy, which varies the Fund's equity exposure based on the risk/reward relationship of the stock market. The Fund is designed to reduce risk by implementing strategies uncorrelated to traditional investments.

The Morningstar proprietary rating reflects historical risk adjusted performance for the period stated. For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly performance (including the effects of sales charges, loads and redemption fees), placing more emphasis on downward variations and rewarding consistent performance. Each share class is counted as a fraction of one fund within this scale and rated separately, which may cause slight variations in the distribution percentages. The top 10% of funds in each category receive 5 stars, 22.5% receive 4 stars, 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.

Beta measures the fund's volatility relative to the stated benchmark. A Beta greater than 1.00 indicates that a fund's historical returns have fluctuated more than the stated benchmark. Standard Deviation measures the annualized variation of the fund's performance against its mean over time. A higher standard deviation is an indication of greater volatility. R² measures the relationship between the fund's performance and the benchmark. A fund that perfectly matches its benchmark has an R² of 100. Sharpe Ratio is a risk adjusted measure of excess return that compares a fund's performance with a risk free return. A higher Sharpe ratio indicates better risk-adjusted performance.
